TERMS & CONDITIONS

ADOPTION AGREEMENT

- All prospective adopters will be vetted prior to adoption
- No animal from us will be bred from
- Adult animals are neutered, vaccinated and micro-chipped prior to being re-homed.
- Kittens are vaccinated and neutered prior to being re-homed
- All cats homed by us will receive adequate veterinary attention should they become ill.
- No cat homed by us will be left alone for long periods of time.
- Cats homed by us must be returned to us in the unfortunate circumstances that the adoptive family can no longer keep them.

ADOPTION WAIVER

We require a donation of a minimum of AED 500 for adoptions. Depending on breed, size or any health issues the animal may have had, which include vaccinations and neutering we may ask for a higher amount. Thank you for choosing to adopt an animal from the RAK Animal Welfare Centre. Your selfless act has provided a home for an unwanted animal. The centre tries to adopt out healthy vet checked animals that have been vaccinated and neutered. If the animal you are adopting has not been neutered, you must arrange for surgery to be performed before the age of 6 months. The cost is included in your donation.

The RAK AWC cannot guarantee the health of the pet you have chosen.

Should the animal you have adopted become seriously ill within the next 14 days, you have two options:

1. You may return the animal to the Centre where you will have the option of having another animal or having your donation refunded.
2. You may keep the animal, and in doing so accept full responsibility for the care and treatment of the animal. The RAK AWC will not be responsible for any costs, procedures, or outcome.

Should you no longer want the animal for reasons other than illness; all adoption fees are non refundable.

REPOSSESSION: Adopter understands that in the event he/she does not follow the terms of agreement or adopter neglects or abuses the cat, the RAK Animal Welfare Centre or another authority has the right to take possession of the pet. The adopter agrees to pay RAK Animal Welfare Centre any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms and provision of this contract.
